ABSTRACT

Abstract should be typed within five lines. All papers to be published in the proceedings of ICFD must be formatted according to the following instructions. This is a T_EX template for preparing your manuscript. If you prefer MS-Word, a template for MS-Word is also available from the conference website. This format uses document class, `icfd2025paper.cls`. Please use it on your own responsibility.

1. Introduction

The paper length should be **two to four pages**. Include:

Title
Name(s) of author(s)
Affiliation(s)
Address(es)
Abstract
Main text including table(s) and figure(s)
Acknowledgments (if applicable)
References
Appendices (if applicable)
E-mail address of the corresponding author

2. Method

2.1 Styles

2.1.1 Layout

The main text is composed of **two columns**. Each column must be 8 cm width and justified. The spacing between the columns must be 1 cm. The left and right margins in a page must be 2 cm, the top and the bottom margins must be 2.5 cm.

2.1.2 Font

Manuscript should be in “Times New Roman” (or equivalent). Font size for the title should be 12 pt, and all other font size should be 10 pt.

2.2 Title

Title should be bold and centered. The author’s name should appear below the title, and his/her affiliation and address should appear on a separate line immediately below the author’s name. They are centered. Underline the speaker. Leave one line between the title and the author’s name, between the author and the abstract, and between the abstract and the main text. All other line spacing should be one line (single spaced).

2.3 Equations

Equations are numbered. Equation number should be right-aligned and the same size as used

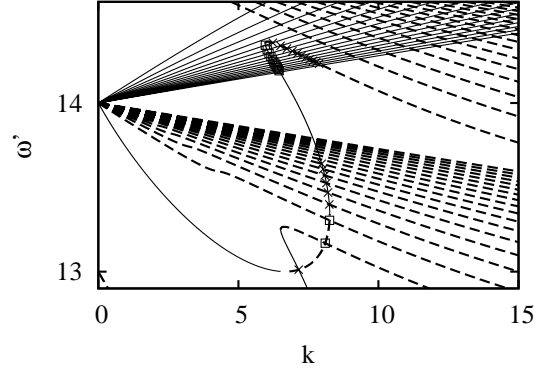


Fig. 1 Figure captions should be below the figure.

2.4 Table and Figures

Figures are reduced to fit within the margins of each column. Symbols and legends should be legible. Tables and figures should be numbered in the order they appear in the text. Color figures are acceptable.

2.5 References

A list of references should be included at the end of the text. References should be numbered in citation order and abbreviated in the appropriate format [1, 2], Initials should precede the author’s name [3].

3. Results and Discussion

Once you have completed your manuscript in T_EX format, please create a PDF file. In T_EX format, submit **PDF file only** from the ICFD web page. (If using the MS-Word template, submit both Word and PDF files.) Manuscripts that do not follow these instructions will be returned to the authors.

4. Concluding Remarks

The proceedings can be downloaded, and the password and URL will be made known on the first day of the ICFD.
